#### **JEREMY FIRESTONE**

Professor, University of Delaware School of Marine Science and Policy

Jeremy Firestone is a Professor in the University of Delaware School of Marine Science and Policy. He employs quantitative and qualitative social science research methods to shed light on social acceptance and energy justice regarding offshore wind power development and evaluates spatial planning to reduce conflicts. His teaching includes a course on offshore wind power and another on ocean and coastal law. He serves on the National Academy of Science Standing Committee on Offshore Science and Assessment and on the Mid-Atlantic Fishery Management Council's Ecosystems and Ocean Planning Advisory Panel. He previously served on the Delaware Governor's Offshore Wind Power Working Group, as North American Wind Energy Academy 2022 Social Science Track Lead, and as Director of UD's Center for Research in Wind (CReW) from 2011-2022. During winter 2023, he was a Fulbright Specialist at the University of Iceland teaching a wind power course and working on Icelandic wind power policy.



#### **RACHAEL GRIFFITH**

Sustainability Director, Chester County Planning Commission

Rachael Griffith is the Sustainability Director at the Chester County Planning Commission. She leads the Planning Commission's Sustainability Division which leads the implementation of the county's Climate Action Plan. She provides leadership and coordination between county departments, municipalities and a host of regional and community partners to collaborate on initiatives to leverage funding, resources, and talent to advance sustainability within the county. Additionally, Rachael leads planning efforts related to Chester County's award-winning open space preservation program and provides resources and guidance to municipalities. Rachael is a PAregistered landscape architect and certified planner. She holds a Master's in Public Administration from the University of Pennsylvania and a B.S. in Landscape Architecture from Temple University.



**EMILY KNEARL** 

Delaware Director of Government Relations and External Affairs, The Nature Conservancy

Emily Knearl has worked in Delaware public policy, community building, and convening partners on strategic planning for over 25 years. She has wide ranging experience in public health, clean water and stormwater policy, climate change, disaster planning, and environmental diversity, inclusion, equity and justice issues. She specializes in identifying and bringing together partners to develop policies using a science-based approach.



#### MICHELLE KOENIG

Director of Conservation and Watershed Planning, Climate and Sustainability Section, Delaware Center for Inland Bays

Michelle Koenig joined the Delaware Center for the Inland Bays as the Director of Conservation and Watershed Planning in 2017. Her primary responsibility is facilitating the implementation of the 2021 Inland Bays Comprehensive Conservation and Management Plan by engaging with partners and the community, identifying coastal resilience and pollution reduction projects, leveraging funding to support implementation, and through policy initiatives. Michelle holds a B.S. in Environmental Studies and Physical Geography from Salisbury University and a Master of Natural Resources degree from Virginia Tech. Prior to working at the Center, Michelle worked for the American Forest Foundation and the USDA Farm Service Agency.



#### ROBERT MCBRIDE

Chair, BikeNewark, Secreatry, The Newark Partnership

Robert McBride was elected Chair of Bike Newark for a second two-year term in November 2020. Before becoming Chair he also served as Treasurer. He grew up in Wilmington and lived in Newark for 8 years during his UD Education (BS and MS). At one point in his career, he worked in New Castle County Head Start Early Childhood Development programs before moving to Virginia to run a Head Start Program in Roanoke. He later moved to Pennsylvania where he worked in education for 35 years. Bob and his wife both retired back to Newark after long careers at George School, a Quaker High School in Pennsylvania. He was a founding member of the White Clay Bicycle Club, and works with the City of Newark and WILMAPCO doing transportation planning. A charter member of The Newark Partnership he is an avid recreational bicyclist, a volunteer urban planner, and a really enthusiastic birdwatcher.



LYNNE PUSEY

Coastal Training Coordinator, Delaware National Estuarine Research Reserve

Lynne Pusey is the Coastal Training Program Coordinator with the Delaware National Estuarine Research Reserve (DNERR). Prior to joining the reserve this past September, she spent the past 18 years working for DNREC in the Division of Parks and Recreation and Division of Fish and Wildlife in varying field and educational roles, most recently as manager of the DuPont Nature Center. In her new role with DNERR and the Division of Climate, Coastal and Energy, Lynne is working to provide meaningful learning opportunities and information for community leaders, natural resource managers and conservation partners.
